1.B. SENSITIVE CONTENT

Policy Reference: EL-1.1

Health Education is a part of the combined Physical Education/Health Education Curriculum. The aim of the Physical Education/Health curriculum is to provide each student with planned and balanced programming to develop the knowledge, skills and attitudes for physically active and healthy lifestyles. Furthermore, there are instances where cross-curricular learning and/or other content area also covers the topics as defined below.

SENSITIVE CONTENT

For student learning outcomes related to potentially sensitive issues, schools must consider parental involvement and alternative delivery models. Sensitive topics include

- Human sexuality/gender
- Substance use and abuse prevention
- Personal sexual and illicit substance safety

Lakeshore School Division recognizes the importance of age/development appropriate content throughout the subject areas and that it is the duty of staff to teach the curriculum, create an environment that respects human diversity, and prepare students to be citizens in a just and democratic society.

PARENTAL INVOLVEMENT

Written communication (letter, e-mail, etc.) is to be sent to the parent/guardian of each Lakeshore School Division student each year, informing them of the alternative delivery option and which classes may be covering units with sensitive topics.

Some of the content and issues pertaining to student learning outcomes may be potentially sensitive for some students and their parents/families and/or communities based on religious and/or cultural values.

Lakeshore School Division will provide an alternative delivery choice for those parents who opt out of the school-based program:

- If the school-based program delivery is rejected by the parent/guardian, it will be the responsibility of the parent/guardian to instruct his/her child based on the Manitoba Health Curriculum.
- Evaluation of performance on the alternative delivery model will be based upon the same benchmarks and rubrics as used in the school-based program. Date of

evaluation will be set by the classroom teacher. It is the parents'/guardians' responsibility to obtain and provide information to the students.

SCHOOL INVOLVEMENT

When requested, schools in Lakeshore School Division will provide information resources, outlining the Health Curriculum for each grade.

Parents may choose an alternative delivery method for these topics, where they would consult with the teacher to cover the content with their own children.

Please also note that this letter covers Health Education and other similar units of study. School staff have an obligation to provide safe spaces for all students and there may be times where sensitive topics are brought forward by students or where these items need to be addressed to comply with other Division and Provincial legislation and policy.
