Dear Parent/Guardian:

Your child has registered for Grade 11 Applied Math for next school year. This course requires a Graphing Calculator. We use the TI-83 Plus. The TI-84 Plus is also acceptable. TI stands for Texas Instruments.

If you are going to purchase the calculator, do not purchase any other calculator than the 2 that are stated above. They are very confusing to figure out at first and there will be no time to figure out any other calculator than the ones listed above.

As the calculators are expensive to purchase, around \$130, the school will provide the opportunity to rent one. We have around 25 that are available to rent.

If you are interested in renting a graphing calculator from the school, please fill out the attached rental agreement form. The school is also asking for a cheque for \$100. This cheque will not be cashed unless your child breaks the calculator. If the calculator is returned in good working condition, your cheque will be returned to you. If your child loses or damages the calculator, your cheque will be cashed to cover replacement. Make the cheque out to "Lakeshore School Division".

The school does not provide batteries for the calculator. Your child must provide 4-AAA batteries.

If you are renting a calculator, please bring batteries, rental form, and cheque on the first day of school, September 9th. We use the calculator starting on day 1.
