1. Support in the writing and implementing of Student Specific Plans
2. Provide professional development for divisional staff
3. Spend majority of time in schools consulting, co-teaching, coaching and directly supporting follow up from incidents
4. Work collaboratively with administrators, Student Services teams, teachers, and parents/guardians
5. Respond to crisis situations
6. Participate in threat assessments
7. Meet with parents

QUALIFICATIONS:

- a) Valid Manitoba Teacher's Certificate or Social Work degree eligible for consideration as a certified school clinician
- b) Minimum of 5 years of varied classroom teaching experience.
- c) Post Baccaalaureate diploma or graduate work would be an asset.

SPECIFIC REQUIREMENTS:

- a) Experience working with students with challenging needs
- b) Experience with behavior coaching and/or co-teaching
- c) Strong interpersonal skills, including a sense of discretion and confidentiality regarding coaching interactions and work with students.
- d) Effective written and oral communication skills.
- e) Leadership ability.
- f) Organizational skills to work independently.
- g) Ability to network within and beyond the school division.
- h) Be a positive influence on the team atmosphere.
- i) Satisfy all the requirements of the Division Policy regarding Child Abuse Registry and Criminal Record checks.
